

Attention Stars & Stripes Readers & members of Congress that chair the House and Senate committees overseeing the armed forces:

(15-July-2009) Recently the Stars and Stripes wrote two articles about members of the military that frequent the NewSaxon.org (NSX). This notice is to inform readers of a few alarming discrepancies.

1. The SPLC states that a few "White Supremacist" websites claim to recruit military personnel for membership because of their "C4 Explosive"* skill. No website owned or operated by the National Socialist Movement or NSM88 Records permits such non-sense – certainly the SPLC knows that however in their lame attempt to justify their existence to their donor base they wanted to try to lead readers into connecting New Saxon & the NSM as being associated with violent and illegal people and/or groups.
2. The SPLC uses current events of violence committed by mentally ill people in an attempt to link the New Saxon website, its' users and the National Socialist Movement to such mental midgets. The SPLC states, "In the wake of several high-profile murders by extremists of the radical right,...""** in an opening statement to Congress on why they should ban New Saxon from military networks.

The above statement is typical of the methodology the Southern Poverty Law Center used to scare lawmakers, the public and others into believing that ANY website or political organization that promotes the rights of European Americans is a rogue, anti-American domestic terrorist organization. The administrators of New Saxon would like to set the record straight in that any and all users of the website must abide by strict rules or conduct. Under no circumstances will any anti-American, terrorist like discussions or any other anti-social – psychotic rhetoric be allowed on the site and any user that attempts to post such non-sense is quickly removed and banned. The New Saxon online community does a great job in reporting such "crazies" when they stop by and the users are quickly removed and banned from the site.

The National Socialist Movement is indirectly involved with the New Saxon site as New Saxon is a project of NSM88 Records – a RAC music label. New Saxon is sponsored by the NSM88 Records Company. In any event, the policy set by NSM88 Records management reflects the rules set forth on New Saxon which ditto those viewed by the NSM. All parties are in agreement in that illegal activity is anti-American and totally and utterly against the common good of the whole message of National Socialism as an alternative to right wing Capitalism and left wing Socialism / Communism.

The National Socialist Movement is an European-American Rights political action group and officially discourages illegal behavior of all kind. The National Socialist Movement has strict membership requirements in that any person or persons to condone, encourage or participate in illegal activity of any kind will face immediate dismissal from the National Socialist Movement.

Just like African Americans have the NACCP – an African-American rights advocate – the National Socialist Movement is a European-American rights advocate that promotes the interests of White people and works to make sure European-Americans continue to have a voice in government affairs. The NSM also actively promotes family values, strong patriotism with a great love for America and a third Party solution to the two Party monopolies which currently govern the United States.

The NSM is Americans “National Socialist Party”, a third Party choice for American citizens looking for change, looking for hope and a bright future. A future where America will truly be first and its’ majority citizens will be treated as such. National Socialism promotes strong nation, family and racial pride while working to put the nation to work – from scientists to farmers ..
